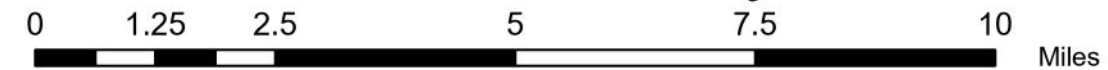


★ Wolf Creek Nuclear Plant — Evacuation Routes — Railroad

Coffey County Sub-Zone Evacuation Routes to Lyon and Woodson County Reception Centers

Subzone CCL (Coffey County Lake)—CCL includes Coffey County Lake and the adjacent land open to the public, including the Wilson Cadman Wildlife Education Area and Black Bear Bosin Shelter house.

Evacuation routes: Lyon County Reception Center: travel north on Highway 75 to I-35S. Take I-35S for 14 miles to Exit 141 for KS-130 toward Neosho Rapids/Hartford. Travel eight miles south to Hartford, then continue on Commercial St. just past Maple Ave. Register at the Lyon County Reception Center located at the Hartford High School, 100 Commercial St. in Hartford.

Woodson County Reception Center: travel south on Highway 75 to Yates Center. At the intersection of Highway 75 and W. Washington Street, turn right (west). Travel approximately two blocks. Register at the Woodson County Rural Fire Station, 809 W. Mary Street in Yates Center.

Subzone CTR—CTR includes Wolf Creek Generating Station and Country Estates subdivision. CTR does not include Sharpe, New Strawn or Burlington. CTR is bordered on the west by Highway 75; on the north by 17th Road; on the east by Reaper Road; and on the south by 12th Road.

Evacuation routes: Lyon County Reception Center: travel north on Highway 75 to I-35S. Take I-35s for 14 miles to Exit 141 for KS-130 toward Neosho Rapids/Hartford. Travel eight miles south to Hartford, then continue on Commercial St. just past Maple Ave. Or, travel west on 12th Road to Angus Road. Take Angus Road north. Angus Rd will turn into Road Y5 at the county line. Continue on Road Y5 north to Hartford. Continue north on Mechanic St. to W. Maple Ave, turn right. Go one block east to Commercial St. Register at the Lyon County Reception Center located at the Hartford High School, 100 Commercial St. in Hartford.

Woodson County Reception Center: travel south on Highway 75 to Yates Center. At the intersection of Highway 75 and W. Washington Street, turn right (west). Travel approximately

two blocks. Register at the Woodson County Rural Fire Station, 809 W. Mary Street in Yates Center.

Subzone E-1—E-1 is bordered on the west by Reaper Road; on the north by 16th Road; on the east by Underwood Road; and on the south by 12th Road.

Evacuation routes: Lyon County Reception Center: travel north to 16th Road, east to Trefoil Road, then north on Trefoil Road to I-35S. Take I-35S 21 miles to Exit 141 for KS-130 toward Neosho Rapids/Hartford. Travel eight miles south to Hartford, then continue on Commercial St. just past Maple Ave. Register at the Lyon County Reception Center located at Hartford High School, 100 Commercial St. in Hartford.

Woodson County Reception Center: travel south on Highway 75 to Yates Center. At the intersection of Highway 75 and W. Washington Street, turn right (west). Travel approximately two blocks. Register at the Woodson County Rural Fire Station, 809 W. Mary Street in Yates Center.

Subzone E-2—E-2 is bordered on the west by Underwood Road; on the north by 16th Road; on the east by Yearling Road; and on the south by 12th Road.

Evacuation routes: Lyon County Reception Center: travel north to 16th Road, west to Trefoil Road, and then north on Trefoil Road to I-35S. Take I-35 for 21 miles to Exit 141 for KS-130 toward Neosho Rapids/Hartford. Travel eight miles south to Hartford, then continue on Commercial St. just past Maple Ave. Register at the Lyon County Reception Center located at Hartford High School, 100 Commercial St. in Hartford.

Woodson County Reception Center: travel south on Highway 75 to Yates Center. At the intersection of Highway 75 and W. Washington Street, turn right (west). Travel approximately two blocks. Register at the Woodson County Rural Fire Station, 809 W. Mary Street in Yates Center.

Subzone JRR (John Redmond Reservoir) —JRR includes all areas on and immediately adjacent to John Redmond Reservoir. JRR does not include New Strawn, Ottumwa or Jacob's Creek.

Evacuation routes: Lyon County Reception Center: travel north on Highway 75 to I-35S. Take I-35S for 14 miles to Exit 141 for KS-130 toward Neosho Rapids/Hartford. Travel eight miles south to Hartford, then continue on Commercial St. just past Maple Ave. Or, travel west on 12th Road to Angus Road. Take Angus Road north. Angus Rd will turn into Road Y5 at the county line. Continue on Road Y5 north to Hartford. Continue north on Mechanic St. to W. Maple Ave, turn right. Go one block east to Commercial St. Register at the Lyon County Reception Center located at the Hartford High School, 100 Commercial St. in Hartford.

Woodson County Reception Center: travel south on Highway 75 to Yates Center. At the intersection of Highway 75 and W. Washington Street, turn right (west). Travel approximately two blocks. Register at the Woodson County Rural Fire Station, 809 W. Mary Street in Yates Center.

Subzone N-1—N-1 is bordered on the west by Highway 75; on the north by 20th Road; on the east by Quail Road; and on the south by 17th Road. N-1 includes Sharpe and the Coffey County Airport.

Evacuation routes: Lyon County Reception Center: travel north on Highway 75 to I-35S. Take I-35S for 14 miles to Exit 141 for KS-130 toward Neosho Rapids/Hartford. Travel eight miles south to Hartford, then continue on Commercial St. just past Maple Ave. Register at the Lyon County Reception Center located at Hartford High School, 100 Commercial St. in Hartford.

Woodson County Reception Center: travel south on Highway 75 to Yates Center. At the intersection of Highway 75 and W. Washington Street, turn right (west). Travel approximately two blocks. Register at the Woodson County Rural Fire Station, 809 W. Mary Street in Yates Center.

Subzone N-2—N-2 is bordered on the west by Highway 75; on the north by Old Highway 50; on the east by Quail Road; and on the south by 20th Road. N-2 includes Halls Summit.

Evacuation routes: Lyon County Reception Center: travel north on Highway 75 to I-35S. Take I-35S for 14 miles to Exit 141 for KS-130 toward Neosho Rapids/Hartford. Travel eight miles south to Hartford, then continue on Commercial St. just past Maple Ave. Register at the

Lyon County Reception Center located at Hartford High School, 100 Commercial St. in Hartford.

Woodson County Reception Center: travel south on Highway 75 to Yates Center. At the intersection of Highway 75 and W. Washington Street, turn right (west). Travel approximately two blocks. Register at the Woodson County Rural Fire Station, 809 W. Mary Street in Yates Center.

Subzone NE-1—NE-1 is bordered on the west by Quail Road; on the north by 20th Road; on the east by Trefoil Road; and on the south by 16th Road.

Evacuation routes: Lyon County Reception Center: travel east to Trefoil Road. Take Trefoil Road north to I-35S. Take I-35S 21 miles to Exit 141 for KS-130 toward Neosho Rapids/Hartford. Travel eight miles south to Hartford, then continue on Commercial St. just past Maple Ave. Register at the Lyon County Reception Center located at Hartford High School, 100 Commercial St. in Hartford.

Woodson County Reception Center: travel south on Highway 75 to Yates Center. At the intersection of Highway 75 and W. Washington Street, turn right (west). Travel approximately two blocks. Register at the Woodson County Rural Fire Station, 809 W. Mary Street in Yates Center.

Subzone NE-2—NE-2 is bordered on the west by Quail Road; on the north by Old Highway 50; on the east by Trefoil Road; and on the south by 20th Road. NE-2 includes Waverly.

Evacuation routes: Lyon County Reception Center: travel east to Trefoil Road. Take Trefoil Road north to I-35S. Take I-35S for 21 miles to Exit 141 for KS-130 toward Neosho Rapids/Hartford. Travel eight miles south to Hartford, then continue on Commercial St. just past Maple Ave. Register at the Lyon County Reception Center located at Hartford High School, 100 Commercial St. in Hartford.

Woodson County Reception Center: travel south on Highway 75 to Yates Center. At the intersection of Highway 75 and W. Washington Street, turn right (west). Travel approximately two blocks. Register at the Woodson County Rural Fire Station, 809 W. Mary Street in Yates Center.

Subzone NE-3—NE-3 is bordered on the west by Trefoil Road; on the north by 22nd Road; on the east by Yearling Road; and on the south by 16th Road.

Evacuation routes: Lyon County Reception Center: travel west to Trefoil Road. Take Trefoil Road north to I-35S. Take I-35S for 21 miles to Exit 141 for KS-130 toward Neosho Rapids/Hartford. Travel eight miles south to Hartford, then continue on Commercial St. just past Maple Ave. Register at the Lyon County Reception Center located at Hartford High School, 100 Commercial St. in Hartford.

Woodson County Reception Center: travel south on Highway 75 to Yates Center. At the intersection of Highway 75 and W. Washington Street, turn right (west). Travel approximately two blocks. Register at the Woodson County Rural Fire Station, 809 W. Mary Street in Yates Center.

Subzone NW-1—NW-1 is bordered on the west by Homestead Road; on the north by 20th Road; on the east by Highway 75; and on the south by 17th Road. NW-1 includes Ottumwa.

Evacuation routes: Lyon County Reception Center: travel north on Highway 75 to I-35S. Take I-35S for 14 miles to Exit 141 to KS-130 toward Neosho Rapids/Hartford. Travel eight miles south to Hartford, then continue on Commercial St. just past Maple Ave. Or travel north on Kafir Road to 19th Road. Take 19th Road to Fauna Road. Take Fauna Road north eight miles to I-35S. Take I-35S to Exit 141 for KS-130 toward Neosho Rapids/Hartford. Travel eight miles south to Hartford, then continue on Commercial St. just past Maple Ave. Register at the Lyon County Reception Center located at Hartford High School, 100 Commercial St. in Hartford.

Woodson County Reception Center: travel south on Highway 75 to Yates Center. At the intersection of Highway 75 and W. Washington Street, turn right (west). Travel approximately two blocks. Register at the Woodson County Rural Fire Station, 809 W. Mary Street in Yates Center.

Subzone NW-2—NW-2 is bordered on the west by Homestead Road from 20th Road to 22nd Road, and by Iris Road from 22nd Road to Old Highway 50; on the north by Old Highway 50; on the east by Highway 75; and on the south by 22nd Road.

Evacuation routes: Lyon County Reception Center: travel west on 22nd Road to Angus Road. Turn South on Angus Road and go 2.5 miles to Hartford, then continue on Commercial St just

past Maple Ave. Or go west on Old Highway 50 to Fauna Road. Take Fauna Road north to I-35S. Take I-35S to Exit 141 for KS-130 toward Neosho Rapids/Hartford. Travel eight miles south to Hartford, then continue on Commercial St. just past Maple Ave. Or go west on Old Highway 50 to Road 175 at the county line. Take Road 175 for two miles to Road X. Turn south on Road X/KS-130. Travel south on KS-130 eight miles to Hartford, then continue on Commercial St. just past Maple Ave. Register at the Lyon County Reception Center located at the Hartford High School, 100 Commercial St. in Harford.

Woodson County Reception Center: travel south on Highway 75 to Yates Center. At the intersection of Highway 75 and W. Washington Street, turn right (west). Travel approximately two blocks. Register at the Woodson County Rural Fire Station, 809 W. Mary Street in Yates Center.

Subzone S-1—S-1 is bordered on the west by Highway 75; on the north by 12th Road from Highway 75 east to Native Road then by 11th Road from Native Road east to Quail Road; on the east by Quail Road; and on the south by 9th Road.

Evacuation routes: Lyon County Reception Center: travel west on 11th Road, then north on Highway 75 to I-35S. Take I-35S 14 miles to Exit 141 for KS-130 toward Neosho Rapids/Hartford. Travel eight miles south to Hartford, then continue on Commercial St. just past Maple Ave. Or travel west on 11th Road to Highway 75, then south to Highway 58. Travel west on Highway 58 to Angus Road. Take Angus Road north. Angus Rd will turn into Road Y5 at the county line. Continue on Road Y5 north to Hartford. Continue north on Mechanic St to W. Maple Ave, turn right. Go one block east to Commercial St. Register at the Lyon County Reception Center located at the Hartford High School, 100 Commercial St. in Harford.

Woodson County Reception Center: travel south on Highway 75 to Yates Center. At the intersection of Highway 75 and W. Washington Street, turn right (west). Travel approximately two blocks. Register at the Woodson County Rural Fire Station, 809 W. Mary Street in Yates Center

Subzone S-2—S-2 is bordered on the west by Highway 75; on the north by 9th Road; on the east by Quail Road; and on the south by Highway 58. S-2 includes Quail Meadows subdivision.

Evacuation routes: Lyon County Reception Center: travel west on Highway 58 to Angus Road. Take Angus Road north. Angus Rd will turn into Road Y5 at the county line. Continue on Road Y5 north to Harford. Continue north on Mechanic St. to W. Maple Ave, turn right. Go one block east to Commercial St. Register at the Lyon County Reception Center located at the Hartford High School, 100 Commercial St. in Harford.

Woodson County Reception Center: travel south on Highway 75 to Yates Center. At the intersection of Highway 75 and W. Washington Street, turn right (west). Travel approximately two blocks. Register at the Woodson County Rural Fire Station, 809 W. Mary Street in Yates Center.

Subzone SE-1—SE-1 is bordered on the west by Quail Road; on the north by 12th Road; on the east by Trefoil Road; and on the south by 9th Road.

Evacuation routes: Lyon County Reception Center: travel south to Highway 58, then west to Angus Road. Take Angus Road north. Angus Rd will turn into Road Y5 at the county line. Continue on Road Y5 north to Hartford. Continue north on Mechanic St. to W. Maple Ave, turn right. Go one block east to Commercial St. Register at the Lyon County Reception Center located at the Hartford High School, 100 Commercial St. in Hartford

Woodson County Reception Center: travel south on Highway 75 to Yates Center. At the intersection of Highway 75 and W. Washington Street, turn right (west). Travel approximately two blocks. Register at the Woodson County Rural Fire Station, 809 W. Mary Street in Yates Center.

Subzone SE-2—SE-2 is bordered on the west by Trefoil Road; on the north by 12th Road; on the east by Yearling Road; and on the south by 8th Road. SE-2 includes Aliceville.

Evacuation routes: Lyon County Reception Center: travel south to Highway 58. Take Highway 58 west to Angus Road. Take Angus Road north. Angus Rd will turn into Road Y5 at the county line. Continue on Road Y5 north to Hartford. Continue north on Mechanic St. to W. Maple Ave, turn right. Go one block east to Commercial St. Register at the Lyon County Reception Center located at the Hartford High School, 100 Commercial St. in Hartford.

Woodson County Reception Center: travel south on Highway 75 to Yates Center. At the intersection of Highway 75 and W. Washington Street, turn right (west). Travel approximately

two blocks. Register at the Woodson County Rural Fire Station, 809 W. Mary Street in Yates Center.

Subzone SE-3—SE-3 is bordered on the west by Quail Road; on the north by 9th Road; on the east by Trefoil Road; and on the south by Highway 58. SE-3 includes LeRoy.

Evacuation routes: Lyon County Reception Center: travel south to Highway 58. Take Highway 58 west to Angus Road. Take Angus Road north. Angus Rd will turn into Road Y5 at the county line. Continue on Road Y5 north to Hartford. Continue north on Mechanic St. to W. Maple Ave, turn right. Go one block east to Commercial St. Register at the Lyon County Reception Center located at the Hartford High School, 100 Commercial St. in Hartford

Woodson County Reception Center: travel south on Highway 75 to Yates Center. At the intersection of Highway 75 and W. Washington Street, turn right (west). Travel approximately two blocks. Register at the Woodson County Rural Fire Station, 809 W. Mary Street in Yates Center.

Subzone SE-4—SE-4 is bordered on the west by Trefoil Road; on the north by 8th Road; on the east by Wayside Road; and on the south by Highway 58.

Evacuation routes: Lyon County Reception Center: travel south to Highway 58. Take Highway 58 west to Angus Road. Take Angus Road north. Angus Rd will turn into Road Y5 at the county line. Continue on Road Y5 north to Hartford. Continue north on Mechanic St. to W. Maple Ave, turn right. Go one block east to Commercial St. Register at the Lyon County Reception Center located at the Hartford High School, 100 Commercial St. in Hartford.

Woodson County Reception Center: travel south on Highway 75 to Yates Center. At the intersection of Highway 75 and W. Washington Street, turn right (west). Travel approximately two blocks. Register at the Woodson County Rural Fire Station, 809 W. Mary Street in Yates Center.

Subzone SW-1—SW-1 is bordered on the west by Iris Road; on the north by 13th Road; on the east by Highway 75; and on the south by 10th Road. SW-1 includes the entire city of Burlington. Patients in the Coffey County Hospital, residents at Life Care Center in Burlington and prisoners at the Coffey County Jail will be taken to appropriate facilities in Emporia.

Evacuation routes: Lyon County Reception Center: travel west on 12th Road to Angus Road. Take Angus Road north. Angus Rd will turn into Road Y5 at the county line. Continue on Road Y5 north to Hartford. Continue north on Mechanic St. to W. Maple Ave, turn right. Go one block east to Commercial St. Register at the Lyon County Reception Center located at the Hartford High School, 100 Commercial St. in Hartford.

Woodson County Reception Center: travel south on Highway 75 to Yates Center. At the intersection of Highway 75 and W. Washington Street, turn right (west). Travel approximately two blocks. Register at the Woodson County Rural Fire Station, 809 W. Mary Street in Yates Center.

Subzone SW-2—SW-2 is bordered on the west by Iris Road; on the north by 10th Road; on the east by Highway 75; and on the south by Highway 58.

Evacuation routes: Lyon County Reception Center: travel south to Highway 58. Take Highway 58 west to Angus Road. Take Angus Road north. Angus Rd will turn into Road Y5 at the county line. Continue on Road Y5 north to Hartford. Continue north on Mechanic St. to W. Maple Ave, turn right. Go one block east to Commercial St. Register at the Lyon County Reception Center located at the Hartford High School, 100 Commercial St. in Hartford.

Woodson County Reception Center: travel south on Highway 75 to Yates Center. At the intersection of Highway 75 and W. Washington Street, turn right (west). Travel approximately two blocks. Register at the Woodson County Rural Fire Station, 809 W. Mary Street in Yates Center.

Subzone W-1- W-1 is bordered on the west by Juneberry Road, on the north by 17th Road; on the east by Highway 75 and on the south by 13th Road. W-1 includes New Strawn, Remer's Point and Hillview Addition.

Evacuation routes: Lyon County Reception Center: Travel north on Highway 75 to I-35S. Take I-35S for 14 miles to Exit 141 for KS-130 towards Neosho Rapids/Hartford. Travel eight miles south to Hartford, then continue on Commercial St. just past Maple Ave. Register at the Lyon County Reception Center located at the Hartford High School, 100 Commercial St in Hartford.

Woodson County Reception Center: Travel south on Highway 75 to Yates Center. At the intersection of Highway 75 & W. Washington Street, turn right (west). Travel approximately two blocks. Register at the Woodson County Rural Fire Station at 809 W. Mary Street in Yates Center.

Subzone W-2- W-2 is bordered on the west by Emmer Road; on the northeast by John Redmond Reservoir; on the east by Iris Road, and on the south by 10th Road. W-2 includes Jacob's Creek.

Evacuation routes: Lyon County Reception Center: Travel west on 12th or 16th Road to Angus Road. Take Angus Road north. Angus Rd will turn into Road Y5 at the county line. Continue on Road Y5 north to Hartford. Continue north on Mechanic St. to W. Maple Ave, turn right. Go one block east to Commercial St. Register at the Lyon County Reception Center located at the Hartford High School, 100 Commercial St. in Harford.

Woodson County Reception Center: Travel south on Highway 75 to Yates Center. At the intersection of Highway 75 & W. Washington Street, turn right (west). Travel approximately two blocks. Register at the Woodson County Rural Fire Station at 809 W. Mary Street in Yates Center.
